Tax Chronology

1933. FIRST SPECIAL SESSION. CHAPTER 18. ENACTED A TEMPORARY TAX OF 10¢/LB ON MALT EXTRACT. TO EXPIRE MARCH 1, 1935. LIQUOR 10¢ PER 36 OZ OR FRACTION. 3¢ ON WINE, 5 ¢ ON MALT LIQUOR PER GALLON

1935. CHAPTER 14. EXTENDED PROVISIONS OF 1933 TO MAY 1, 1935.

1935. CHAPTER 78, PP. 341-363. APPROVED MARCH 23, 1935 WITH EMERGENCY CLAUSE. TAX ON MALT EXTRACTS 10¢ PER POUND. REPEALS 1933 FIRST SPECIAL SESSION. CHAPTER 18. LIQUOR 5¢ PER 8 OZ, 5¢ 16 OZ WINE OVER 24% ALCOHOL, 3¢ PER 16 OZ 24% OR LESS.

1945. THIRD SPECIAL SESSION. CHAPTER 12. INCREASED ALL TAXES. 15¢ PER 16 OZ ON MALT SYRUP

1962. CHAPTER 142. INCREASED TAXES. MALT EXTRACT THE SAME. .45¢

1967. THIRD SPECIAL SESSION. CHAPTER 9. LIQUOR AND WINE TAXES INCREASED.

1969. CHAPTER 108. LIQUOR \$2 PER GALLON PROPORTIONATELY.

1973. CHAPTER 173. CREATED DEPARTMENT OF REVENUE.

1974. FIRST SPECIAL SESSION. CHAPTER 2. LIQUOR \$2.50/GAL.

1980 CHAPTER 148 (NO MENTION OF STAMPS)

1983. CHAPTER 185. REPEAL MALT EXTRACT TAX.
