### *Membership Responds Favorably To New Offering*

Response to the idea of an SRS auction posed in the March-April *SRN* was extremely positive and plans are underway to have Mail Auction #1 appear in the September-October issue. The auction will close November 14.

Consignments for the auction are being accepted through August 1. Since there are so few places to buy and sell state revenue stamps this auction will provide members the opportunity both to dispose of duplicates as well as to add pieces to their collections.

Only SRS members may participate in the auction. There will be no reserves but sellers may bid on their own lots. A ten percent commission will be charged to sellers. There will be no buyer's commission.

*SRN* editor Peter Martin will conduct the auctions until a full-time auctioneer is found.

## Duck Society Formed

The formation meeting of the National Duck Stamp Collector's Society was held March 14 in New York City.

Since 1987, the idea of a group devoted to duck stamp collecting had been on the back burner of my mind. Heck, every other group of collectors had an organization, so why not the duckers?


It took over three years and the accumulation of names from my own advertisements, but finally a group of several hundred interested was formed. The next step was to hold an election, develop by-laws and obtain the necessary non-profit incorporated status. Now all are done with the exception of the latter.

When the idea was developing, my main concern was that it should be a "collector" group, and not commercialized. Naturally, dealers would benefit indirectly; nothing wrong with that, but I purposely omitted dealers from the officer candidates to avoid conflict. The society's charter officers are a very competent group. I feel it would be tacky to list their professions and accomplishments, so trust me on this one.

The president is Nick Oglesby; vice president, Gene German; treasurer, John Remaley; secretary, Peter Pierce; newsletter editor, Cecil Daniels; and membership chairman, Dave Green.

The Society's by-laws also provide for up to eight governors, to assist in steering the group. Elected at the first meeting were Norma Opgrand, U.S. Fish and Wildlife Service, William Webster, Wild Wings Chairman, Wayne Roddick, Canada Wildlife Habitat, and, I am very honored to say, myself.

Taken from a recent announcement of the NDSCS is the following regarding their mission: "The primary purpose of the Society is to promote and encourage the collecting and study of migratory waterfowl hunting



and conservation stamps, commonly known as Duck Stamps. In addition to a newsletter, this will be accomplished by educational activities such as meetings,

seminars, exhibits, lectures open to the public; working with federal and state governments as well as worldwide governments and conservation agencies on their Duck Stamp Programs; encouraging realistic valuations of Duck Stamps and adjuncts thereto, such as Appreciation Certificates and ducks on license, and encouraging fraternal and collector relations.

In short, we are interested in promoting the hobby of Duck Stamp collecting and in so doing will assist in the preservation of wetlands through Duck Stamps. The Society will hold an annual meeting of the Executive Board in open session and an annual meeting of the membership each year, during the time and place of the Federal Duck Stamp Contest competition.

A logo is also in the final stages of development. The artwork uses the basic background of Scott RW1, the 1934 issue by artist J.N. "Ding" Darling. The hen mallard is pronounced and moving off the stamp on the left, and the Society's logo is on the right. The logo artwork was prepared by Houston artist and stamp collector, David Connolly.

Membership to the Society is only \$20 per year. Other type memberships are also available, including Juniors, Life, and Charter Life. The Society promises to be very worthwhile, even if you do not collect duck stamps. The information on state stamps overlaps other stamps and printing technologies, and the stores of the duck stamps will interest collectors and non-collectors alike.




# State Revenue News

## States Announce Stamp Availability

### Arkansas

Arkansas has made its 1989-90 through 1991-92 waterfowl and 1991 trout stamps available to collectors. Further details can be obtained from the Arkansas Game & Fish Division, Collector Stamps, 2 Natural Resources Drive, Little Rock, AR 72205. There is a hunter series stamp in booklet form that requires a minimum purchase of one booklet. The SRS plans to order one book of 20 of the 1989-90 Waterfowl stamp and sell the individual stamps for \$6.50 each.

### Minnesota

Minnesota has trout stamps (1982-5, \$3 each; 1986-91, \$5 each) and pheasant stamps (1983-91, \$5 each) available for collectors. Write to Minnesota DNR License Bureau, 500 Lafayette Road, St. Paul Mn 55155-4026. Payment by money order or cashier's check.

### New Jersey

New Jersey has its 1991 waterfowl, 1987 woodcock, 1986 trout (resident and non-resident) and 1986 pheasant/quail stamps available for sale to collectors. For full details, write to New Jersey Division of Fish, Game and Wildlife, CN 400, Trenton, NJ 08625-0400.

The State Revenue Society will purchase a quantity of the woodcock, trout (resident and non-resident) and pheasant stamps and make them available for 50 cents each.

### Maine

Maine will sell its 1991 duck stamp until June 30, after which all unsold stamps will be destroyed. Previous issues (1984-1990) were sold under the same procedure and are available only from collectors and dealers. Unsigned stamps are \$2.50 and signed stamps are \$5. For additional information write the Maine Department of Inland Fisheries and Wildlife, Duck Stamp, Station 41, Augusta, Maine 04333.

Also available for \$1 each are muzzleload (alien, non-resident and resident) and pheasant stamps from 1986 to 1990.

### New Mexico

New Mexico has made its 1991 waterfowl stamps available to collectors. Further details can be obtained from the New Mexico Department of Game & Fish, Villagra Building, Santa Fe, NM 87503.

Because the stamps and prints are sold through Steiner Prints in San Francisco (1-800-225-3971) and there is a \$4 shipping and handling charge per order, the SRS plans to order 20 copies of the \$7.50 stamps to save SRS members this fee.

### West Virginia

West Virginia has made its 1992 Migratory Waterfowl Conservation Stamp available to collectors. Resident and non-resident stamps are available as Individual (\$5.50 each), Artist Signed (\$8.50 each), Corner Block of 4 (\$22.50 each), Booklet of

5 (\$27.50 each), and Sheet of 30 (\$165 each). Further details can be obtained from the West Virginia Division of Natural Resources, Waterfowl Stamp Program, PO Box 67, Elkins, WV 26241.

## Maryland, Minnesota Raise State Cigarette Tax Rates in May, July

Effective May 1, 1992, the Maryland cigarette tax rate is increased from eight cents to 18 cents per pack of 10 or fewer cigarettes and from 16 cents to 36 cents per pack of at least 11 and not more than 20 cigarettes.

The rate is also increased from 0.8 cent to 1.8 cents per cigarette in a pack of more than 20 cigarettes or in a pack of free sample cigarettes.

A licensed wholesaler is allowed a discount of 1.36 percent (formerly, 2.7 percent) of the purchase price of tax stamps.

On April 23, the governor of Minnesota

approved a measure increasing the tax on cigarettes weighing not more than three pounds per thousand from 21.5 mills to 24 mills per cigarette (from 43 cents to 48 cents per pack of 20 cigarettes), effective July 1, 1992. The tax on cigarettes weighing more than three pounds per thousand is increased from 43 mills to 48 mills on each cigarette.

The discount allowed to distributors is reduced from 1.1 percent to 1 percent of the first \$1.5 million of cigarette stamps purchased in any fiscal year and from 0.65 percent to 0.6 percent on the remainder of such stamp purchases. (*State Tax Review*)
