

A SALES TAX SIDELIGHT: THE SHERRILL COUPON METHOD

The mid-1930's were the heyday of sales tax stamps, punch cards, scrip, and tokens. The reader may already be familiar with the complex and fascinating sales tax series of Ohio well-documented by Messrs. Bloom and Hubbard, the scarce Kentucky state issues, and the Michigan Kroger Market coupons. The Sherrill method is a contemporary of all these, and is strikingly similar in design and principle to the Krogers. Let me say early that the series described below were, as far as I know, never adopted by the state of Pennsylvania or any other public or private issuing source, and they are probably only promotional samples, although they have been listed by Emil DiBella under Pennsylvania. The samples were accompanied by a small brochure titled, Brief Statement of the Sherrill Coupon Method of Collecting Sales Taxes, and "Copyrighted 1935 by C. O. Sherrill" of Philadelphia. The folder explained a complex method in which a state agent would check periodically with the merchant to assure compliance with the collection procedure.

Booklets: In the five booklets that I had the opportunity to examine the coupons came in sheets of five, which were stapled between cardboard-dovers. There were fourteen sheets to each book and the covers read as the example to the left. Other covers had the following denominations accompanied by the same text: 30¢/\$10.00; 60¢/\$20.00; \$1.50/\$50.00; and \$3.00/\$100.00. The 15¢ booklet was in manila cardstock, the others brown. The back covers were blank as was the reverse of the front cover. The books had five punched holes, one through each coupon, probably to indicate cancellation of the sample in the event that they were ever adopted.

Coupons:



Each single receipt is 22 x 45 mm and is printed in black ink, except for the word "PENNA." and the serial number which are in red. Reverse were blank and un gummed. Separations were rouletted. Each denomination had its own color and some had two. Note the denomination, 1/2 Cents on 25 Cents, which is probably an error, as all of the other coupons were set up for a 3% tax. The corresponding coupon (in another color) is 3/4 Cents on 25 Cents. The coupons are printed on safety paper and there were three different paper manufacturer's watermarks as follows:

The Sherrill pieces are at least scarce and may be rare. There is no price on them that I know. They are collected not just by philatelists, but numismatists as well, especially sales tax token collectors. The booklets I examined came from the collection of one of the early pioneers in the latter field, Mr. George W. Magee, Jr., of Pennsylvania.

This article is partial preparation for a more extensive work on sales tax pieces of many varieties. It will be a collaborative effort between myself and Jerry Bates of the St. Charles Numismatic Trading Center, P. O. Box 546, St. Charles, Missouri.

I am interested in acquiring the Kentucky, Michigan, and some of the Ohio pieces for further study, either by purchase, trade, or loan. For those interested or having pieces or information on these my address is: Jerry F. Schimmel, 40 Prentiss Street, San Francisco, CA 94110.

STATE STATUTES AVAILABLE - These are a valuable source of revenue information and from the laws one can determine when a tax was first imposed or discontinued, tax rates at various times which help date stamps, changes in method of collection, etc. The library of most any University law school will have these statutes for all states. Terry Hines, who is now a student at Duke University, has access to such a library and has volunteered to furnish photocopies of any State Statute at a cost of 10¢ per page plus postage. We imagine he expects you to give the citation; however the search is not especially difficult for one familiar with this type of material, and if you are confronted with such a research problem but don't know where to start you might inquire to see if he can assist. His new address is given in the Secretary's report in this issue. Your editor also has access to such a library and will assist in verifying data if you have a manuscript otherwise ready for publication.





Mule Deer Hunting Stamps

Reported by the Game and Fish Dept. as first issued in 1959. Although mint copies of some years exist without serial numbers it is believed all regularly issued stamps were numbered. All sizes listed are overall.

- 1961 \$1.00 green on white paper. Standing buck mule deer. Green serial no. $41\frac{1}{2}$ x 57 mm. From vertical panes of 4 (2 x 2), 83 x 127 mm including 13 mm selvage at top. Roul $6\frac{1}{2}$ between stamps and at top selvage.
- 1962 Type 1- \$1.00 black on white paper. Running buck deer. Black serial no. 45 x 62 mm. Roul $9\frac{1}{4}$. From vertical panes of 4 (2 x 2) similar to 1961.
- Type 2- \$1.00 black on green paper. Design same as Type 1. Black serial no. 41 x $57\frac{1}{2}$ mm. From horizontal panes of 2 (2 x 1), imperf all four sides and roul $9\frac{1}{4}$ between stamps.
- Type 3- \$1.00 same as Type 2 except stamps roul $9\frac{1}{4}$ at top or bottom only and imperf all other sides. Believed from vertical panes of 2 (1 x 2).


PENNSYLVANIA BEER "TAX PAIDS" - Chas. Hermann sends 3 varieties which are printed on the bottom of beer cans. These metal items are hard to mount and impossible to illustrate on our electronic stencils. All read "PENNSYLVANIA MALT BEVERAGE TAX PAID ONE PINT OR LESS" around the border and incorporate a keystone design in the center. The Keystone for Budweiser has an eagle and "A" in it; this is in red. The other 2 do not give the brand, but Charles includes a note indicating this is Neuweiler. Both have "PENNSYLVANIA/MALT BEVERAGE/TAX CROWN" in three lines in the Keystone and are in black. One is on 'silver' and the other 'gold' metal.

SOUTH CAROLINA BEER - Charles Hermann sends the $\frac{1}{2}$ barrel in red. All previous issues read "16 Gallons"

BALTIMORE CITY TOBACCO STAMPS DESTROYED








\$25.00 Deer - Bow. Black on pink. Resident deer bow stamp was used by blocking out "Resident" and "\$6" and stamping in "NON RES" and "\$25" in black.

\$25.00 Antelope - Bow. Black on blue (as reported by Dept. of Game and Fish. May possibly have been the resident Antelope Bow stamp overprinted in a manner similar to conversion of the resident deer bow stamp for nonresident usage. Information wanted.

The Dept. of Game and Fish states that Antelope (firearms hunting) or Turkey hunting stamps were not issued to nonresident hunters.

All stamps are printed text with black serial numbers. Approximate overall size 48 x 35 mm. All are from vertical panes of 5 (1 x 5) with black 7 horizontal rouletting between stamps and at top selvage.





WEST VIRGINIA CIGARETTE - Mr. Litchberger sends a copy of the water-transfer decal mentioned in the last issue. This is red on white, black number.

Crow Control Stamps

Although in no sense a license stamp and purchase was not required to shoot crows, classed as predators, these stamps were sold by the N.D. Dept. of Game and Fish and by all County Auditors. Money collected was to create a fund to pay a bounty on crows. Stamps are dated 1945 but are known to have also been sold in 1946.

OHIO LOCAL TAX ON AUTOMOBILE LICENSES - O. R. Bloom

A letter from Mr. F. L. Frank, Administrative Assistant, Ohio Bureau of Motor Vehicles, states "Kindly be advised that Montgomery County was the only county to levy the \$5.00 tax in the 1968 registration year".

PENNSYLVANIA

Non-Resident Trout Stamps

First issued for 1956 season. These stamps were issued on a reciprocal fee basis determined by comparable fee charged by angler's home state to Pennsylvania anglers. Fees ranged from \$5.00 to \$20.50.



- 1956 Green on white. Trout leaping for mayfly. Blank space for fee to be written in. Approx 35½ x 53 mm overall. Perf 12½. From sheets of 30 (6 x 5) imperforate all four sides measuring approx 214 x 265 mm.
- 1957 Purple on white. Trout leaping for mayfly. Blank space for fee to be written in. Approx 34½ x 51 mm overall. Perf 12½. From sheets of 30 (6 x 5) imperforate all four sides measuring approx 206 x 255 mm.
- 1958 Black on yellow surfaced paper. Trout leaping for mayfly. Space for fee write-in eliminated. Black serial number. Approx 33 x 50½ mm overall. Perf 11 3/4. From horizontal booklet panes of 6 (3 x 2) measuring 113 x 101 mm including 14 mm perforated selvage at left. Five panes per booklet.
- 1959 Blue on pink. Perf 12½. All other detail same as 1958.
- 1960 Blue on dull yellow. Perf 11 3/4. All other detail same as 1958.
- 1961 Blue on white. Blue serial no. All other detail same as 1960.
- 1962 Blue on pink. All other detail same as 1960.
- 1963 Blue on green. All other detail same as 1961.

Discontinued after 1963.

BEEES BUZZ IN UTAH - A report from M. E. Matesen

In my recent vacation to Utah I took time out to make a visit to the State Capitol in Salt Lake City and check around on the use of any new tax stamps by the state and much to my surprise an old one we are all familiar with has been amended and re-enacted by the state:

UTAH OLEOMARGARINE TAX STAMP

Effective 1 July 1969, Utah re-enacted the Oleomargarine tax and an excerpt from the new state law is quoted herewith:

"There is imposed and there shall be paid to the State Tax Commission an excise tax upon the first sale, use, storage, or consumption of oleomargarine in the state of Utah at the rate hereinafter set forth:

- (1) Upon Oleo, not artificially colored, 5¢ per pound or fractional part thereof.
- (2) Upon Oleo, artificially colored, 10¢ per pound or fractional part thereof."

In an attempt to purchase some of these stamps from the State Auditor, he stated that "The stamps could only be sold to licensed and bonded dealers as provided by state law" so I went to a local market and purchased a 1-lb of Oleo to obtain the stamp. They are a 18½ x 25½ mm pressure sensitive die-cut stamp. The 10¢ has a green frame line running around the top and sides with the words "Utah" in heavy bold green type at top with "Tax Paid Oleomargarine" in semicircle below. Beehive in the center with the value "10¢" at its base. I tried to obtain copies of the 5¢ stamp but uncolored Oleo is something hard to find in the markets nowadays. These stamps are prepared in rolls of 500 each. In future conversation with the Miscellaneous Tax Division Officer he told me the state also uses a \$1.00 and \$5.00 stamp for larger volumes of Oleo and that these stamps were required to be affixed to the sales invoices and held by the purchaser for an indefinite period since the state made periodic inspections to insure that the law was being adhered to and the stamps being used. Failure to do so could cost the offender a \$25.00 fine for each offense. The state law also provided that any misuse of the stamps (counterfeits, reuse, etc.) is guilty of a felony and could receive a \$1,000 fine and five years in jail.




There are no Oleomargarine producing companies within the state so all of the stamps are either applied prior to arrival in the state for sale, consumption, etc., or affixed to the Oleo or invoice as applicable within 72 hours after arrival in the state as provided by state law.

I failed to obtain information on the color, size, etc. on the 5¢, \$1.00 and \$5.00 but as soon as I do I will send it on for publication in the Newsletter.

I hope to obtain a few copies of the 10¢ Oleo (if my relatives each obtain a lot) and when I do I will make them available to collectors interested for a self-addressed stamped envelope. (Mr. Matesen does not have extras available at this time).

UTAH CIGARETTE TAX STAMPS - Current tax is 8¢ per pack of cigarettes/cigarette papers. Utah is presently using four types of cigarette tax stamps. They are:

- (1) PB meter imprints - purple imprint
(This has been in use for some years)

(2) Heat Fuson Decals (Two types) - prepared in rolls of 500 each.

a) Gold background, black lettering

"Utah" across top, "Tax Paid"

"Twenty Cigarettes" across bottom with beehive in center. Black and white border with red safety.

(This issue has been in use for several years)

b) same as above but background in green with black & yellow border and red safety.

(3) The fourth type of stamp in use is a water transfer decal which is issued in card form of 100 stamps each with black rouletting separating each block of 10. Each stamp has a pink background with white border and lettering. "Cigarette Stamp Tax" around center in white with honeycomb design center.

One of the above are required to be affixed by the distributor, jobber, wholesaler etc. to each pack of cigarettes or cigarette papers. All other tobacco products are taxed by letter report which is required to be made to the State Auditor on a quarterly basis. Again the state law provided that "cigarette revenue stamps will be sold only to licensed and bonded dealers". Attempts to obtain these for collectors also fell on deaf ears of the state officials. But I would like to extend my appreciation to them for all of the information they provided me.

UNMOUNTING STATE REVENUES

Most of us have from time to time run into stamps pasted down with with rubber cement, Elmer's glue, scotch tape, etc. Early collectors of used decals were especially guilty of using these verboten materials; scotch tape was a favorite because this was a convenient way of securely "preserving" these fragile items. Art Soderling has written the manufacturers of these products for information on solvents:

Elmer's Glue-All (Borden Inc.) - This is a polyvinyl resin glue. Direct application of steam to the affected area is recommended. This will cause the glue to flake up and it can be brushed away. But the manufacturer will not guarantee the result. They suggest using Elmer's School Glue which washes off with soap and water!

Scotch Tape (3M Co.) - It is suggested that stamps be soaked in toluene or trichloroethylene for about 30 minutes. Toluene can be purchased at most drug stores. Trichloroethylene is preferred since it is less irritating to the skin; it can be purchased at most hardware stores as duPont's Tri-Cleaner. Warning - The manufacturer advises that the action of either of these solvents is likely to cause the stamp to fade to some extent. Experiment with stamps of little value. Again, results are not guaranteed.

Rubber Cement - Thinners sold for these products would seem a good bet; these usually contain hexane. This also may affect some inks.

If at all possible, use some sort of protective mounts for fragile items like decals. Your editor now transfers liquor, etc. decals to an acetate backing which provides rigidity and also permits inspection of safety designs and then inserts this into a protective mount. Cigarette decals are left on the original cellophane background. Some of our members still use Scotch tape, but in a way which permits remounting. The stamp is centered on a slightly larger background, cellophane or other transparent material of the same size as the background is laid over the stamp, and this covering is then taped in place. This procedure seems safe as the tape does not come in direct contact with the stamp and it can be remounted at any time by simply cutting away the edges of the mount to free the stamp.

MORE MICHIGAN APPLES 'AVAILABLE' - Mr. Siefen paid a personal visit to the Apple Commission office and found that they not only have a number of old issues still available but also several previously unreported new (?) issues. Although mail orders still seem subject to the minimum purchase requirement of full sheets, Mr. Siefen has volunteered to obtain these in singles for members who are willing to pay 10% over face. He will furnish the best copies possible, subject to restrictions imposed by the Apple Commission and availability at the time of his next trip in early December. Members desiring any of these stamps should send payment and a self-addressed stamped envelope to Mr. Siefen before Dec. 5. His address is John F. Siefen, 14344 Archdale St., Detroit, Mich. 48227. Specify clearly which stamps you want him to obtain.

Mr. Hubbard sent photocopies indicating that 2 sizes of values occur on the large stamps. However so far as we can determine, there is only 1 type for any one denomination.



Combining information sent by Mr. Siefen, Terry Hines and El Hubbard, it appears that the following varieties are available:

Large stamps as illustrated on left above-

- 1¢ red
- 1½¢ black on yellow
- 2¢ purple
- 3¢ black on tan
- 5¢ blue
- 10¢ orange
- 25¢ black
- 50¢ dark green
- \$1 violet
- \$5 black on green
- \$5 black on green (different shade)

Whether or not this is a major variety is not known at this time.

Small stamps, value vertical in right panel (like center illustration)

- 4¢ black on blue
- 10¢ orange
- 25¢ black
- \$1 light violet (reads "\$1.00")

Similar, but value horizontal (Like illustration on right above)

- 3¢ yellow
- \$1 violet (reads "\$1")

Apple Card-
4¢ green

To obtain 1 copy of each of the above would cost \$14.43½ (+10% = \$15.88 total). However members may order only those values they desire.

The new tax rate on apples is:

- 1¢ per bushel, 2¢ per cwt on juice, cider and vinegar
- 3¢ per bushel, 6¢ per cwt on processing sales
- 4¢ per bushel, 8¢ per cwt on fresh apple sales

This may mean other new denominations will be coming out in the reduced size when the old ones are gone. Mr. Siefen promises to keep us posted.
